Barks and Recreation Owner Agreement

Accuracy and Disclosure:

Owner acknowledges and agrees that all the information provided to Barks and Recreation is complete and accurate to the best of their knowledge. Owner certifies that Pet is in good health, up to date on required vaccinations (Rabies, Bordetella, and DHLPP), has not been sick during the last 30 days and is free from any communicable diseases. Owner agrees to complete and turn in up-to-date veterinary records to include in Barks and Recreation Pet file. Owner agrees to maintain regular flea, tick, and heartworm prevention as long as Pet is in attendance at Barks and Recreation. Owner acknowledges and agrees that Pet is not aggressive and does not have threatening behavioral problems. Owner certifies that Pet has never harmed itself, another pet or human. Owner understands, and acknowledges that each time Pet is brought in to Barks and Recreation, Owner is recertifying that the Pet is in good health and has not been exposed to any communicable diseases of any kind within the last 30 days. Owner agrees that if fleas or ticks are spotted on Pet at any time during their stay, Barks and Recreation may administer a flea and tick bath, or oral medication, at the Owner's expense. Barks and Recreation reserves the right to refuse service to any Pet for any reason, at any time.

Liability:

Owner acknowledges that Barks and Recreation maintains every effort to keep every dog and human safe at all times in and around the facility, and that the concept of Barks and Recreation Doggy Day Care is to allow dogs to socially interact with other dogs and humans during daycare and boarding activities. Owner releases Barks and Recreation, its employees, and any agent associated with Barks and Recreation of any kind suffered by Owner, Pet, or anyone picking up or dropping off Pet, for any injury, behavioral problem, health problem, and/or illness of Pet, including without limitation, death. Owner voluntarily accepts these risks, and fully releases Barks and Recreation, its employees, and any agent associated with Barks and Recreation from any and all claims arising out of injury or damage in any way related from associating with Barks and Recreation. Owner agrees and understands that dogs are unpredictable animals and Owner will be responsible for any and all costs associated with any kind of injury to their Pet, including but not limited to veterinary bills. In the event that Barks and Recreation employees transport Pet to or from facility, Owner releases Barks and Recreation from all liability in the event of an accident or injury during transportation. Owner agrees that Barks and Recreation liability will never exceed the lesser of the current value of the Pet of the same breed, or a lump sum of \$200 per Pet.

Acceptance of Risk:

Barks and Recreation strives to maintain a safe and healthy environment for our guests, but Owner fully understands that animals are unpredictable and there are potential risks involved with interactions between dogs and humans, as well as dogs and other dogs, which may result in property damage or bodily damage, including, but not limited to illness, disability, or death to dog or human. Owner fully accepts and assumes all risks and responsibilities for all risks, including but not limited to death, veterinarian expenses, losses, damages, any cost, or any form of sickness, including but not limited to communicable disease contracted by Pet at Barks and Recreation.

Veterinarian Liability and Release:

Owner acknowledges and agrees that Barks and Recreation reserves the right to obtain medical treatment for Pet if Barks and Recreation believes in any way that Pet may be ill, injured, or needs medical attention. Barks and Recreation will attempt to contact the Owner, the Veterinarian on file, and the emergency contact for Pet, but obtains the right to seek a Veterinarian of choice if we cannot contact or transport to listed Veterinarian. Owner grants Barks and Recreation employee(s) full power of decision making involving medical treatment and Owner will be fully responsible for all costs associated with the transportation to the veterinarian, and any bills associated with seeking help for Pet.

Abandoned Dogs:

No Pet shall be left at Barks and Recreation past scheduled timing of visit. If Pet is left at Barks and Recreation for more than seven days past scheduled pick up date without hearing from Owner, or any person on approved pick up list, Barks and Recreation will become the legal guardian over Pet. Barks and Recreation reserves the right to seek a new home for Pet after seven days of abandonment. Owner fully acknowledges and agrees that if Pet is abandoned at Barks and Recreation, Owner may not be able to retrieve Pet and cannot take any recourse against Barks and Recreation.

Payment:

All payment is due at or before pick up. Owner agrees that Pet may not leave the facility until all charges due are paid by Owner or payment arrangement is agreed upon by both parties. Owner agrees to pay any collections costs and the cost of a returned check or debit charge. Owner agrees to pay any late fees associated with late or emergency pick-ups.

Owner acknowledges that "Pet" in the use of this contract refers to all pets under the ownership of Owner. Owner has read, understands, agrees to, and acknowledges all of the above.
